The latter, angled in shortly after the start, dueled with MAYOR STEVE throughout and was edged in a game effort. CATEGORY FIVE with the leaders early, chased the pace and tired. SMART REVENGE tired while chasing the pace. QUINCEY'S KREW was outrun after breaking slowly. NICE APPEAL clipped heels with SALTY GLANCE shortly after the start and trailed. Following a stewards inquiry SALTY GLANCE was disqualified and placed sixth for interference to NICE APPEAL shortly after the start.
