**Footnotes**

KRIS AND ME reserved off the pace, saved ground into the far turn, eased out while moving up, then angled outside the leaders in early stretch for racing room, then rallied with EXTENDED FAMILY to gain the lead inside the eighth pole and was all out to edge that rival to the wire. EXTENDED FAMILY rated off the pace, raced three wide on the far turn, then rallied with KRIS AND ME through the stretch while being edged to the wire by that rival. BIG BLUE KITTEN allowed to settle, saved ground to nearing the stretch, swung out for the stretch run and finished willingly to be up for the show. WILD REVENGE taken in hand early, swung out for the stretch run while moving into contention but didn't do enough late while being outfinished for the show. GUNNA GETCHA stalked the pace three wide, made a run to gain a slim lead at the top of the stretch, then weakened in the final eighth. CRIMINAL SAGA unhurried early, improved his position without threatening. EQUIVOCATION failed to menace. SCAPPARE chased the pace along the rail to nearing the stretch, then tired. MYHORSEOFCOURSE was never a factor. ALEJANDRO chased the pace, moved up to reach near even terms for command leaving the far turn, then vied with GUNNA GETCHA to the eighth pole and faltered. RIGGAN raced quickly to the lead after a good start, set the pace along the rail

to the three eighths pole when caught by foes ranging up on the outside, battled to the eighth pole then stopped. SPEAK THE WORD steadied at the start and outrun.
