CUT FOR LUCK set the pace along the rail, drew clear in the stretch and remained clear to the wire under pressure. SWEETSOUTHERNQUEEN rated off the pace, angled out for the stretch run and rallied to gain the place. ROLL THE DI unhurried early, advanced three wide around the far turn to reach the attending position but had no further response. R VICARIOUS GIRL chased the pace into the stretch and gave way. GIRL SLEUTH failed to menace. GATOR'S TRACKS stalked the pace along the inside to nearing the stretch, then tired. TRIGGER FISH LANE was no factor after being pinched back at the start. A LITTLE OFF saved ground and never threatened. NIKKIANDME chased the pace to midway of the far turn, then faltered.
