Footnotes

SMOOTH DADDY stalked the pace off the rail, moved to take over in early stretch and edged away while drifting out. PALACE GATE rated off the pace after being forced out entering the first turn when STROLL TO VICTORY clipped heels, angled out leaving the far turn and rallied to be up for the place. DYLAN WARD reserved early, raced four wide around the far turn and rallied to just miss the place. SAA MI taken back after being steadied in behind STROLL TO VICTORY entering the first turn, saved ground while rallying to loom a threat in midstretch, then flattened out. DECISIVE EDGE set the pace along the rail, opened a commanding lead down the backstretch, made the pace into the stretch and gave way. SHELDON saved ground to no avail. SPORTSCASTER failed to menace. STROLL TO VICTORY clipped heels entering the first turn, recovered and advanced three wide around the far turn to

reach contention, then tired in the drive. LOVES LAST CHANCE was not a factor. SMART SPREE tracked the pace three wide to nearing the stretch and faltered. MILL CREEK was outrun. CASPIAN SEA showed little. DAYNE'S PULPIT showed nothing after breaking poorly. CUPPA JOE was never close.
