VAPOR TRACE chased the pace four wide, then was put to pressure nearing the quarter pole and rallied to be up late. WITTY KID steadied in the chute, moved up racing down the backstretch to vie for the lead outside STAMP OF APPROVAL to past the eighth pole and continued on with good courage while unable to resist the winner late. WALKAMILEINMYSHOES off slowly, was reserved off the pace, then closed to gain the show while unable to get to the top ones. OLD PARR pressed the pace three wide to nearing the stretch, then gave way. STAMP OF APPROVAL moved up on the backstretch to vie for the lead along the rail to inside the eighth pole, then tired. JOHARLINGTON saved ground and failed to menace. UNTAMEABLE was not a factor. RAEALYN'S FRIEND was outrun. AFTER THE FIRE was never a threat. MOW'S REWARD showed little after breaking slowly. COUNTY TRICK showed brief speed and faltered. PHIL'S FIRST raced four wide, faded and was eased in the stretch run.
