Footnotes

FLY SO FAST chased the pace three wide, rallied to engage the leaders soon after entering the turn, then dueled with BOLD STYLE to the wire and prevailed. BOLD STYLE vied for the lead along the rail, responded when FLY SO FAST joined the leaders, then dueled with that rival and continued on gamely while being edged to the wire. E STREET SHUFFLE off slowly, rushed up to vie for the lead outside BOLD STYLE to nearing the sixteenth pole, then weakened. OMRICON unhurried early, advanced to reach contention in the stretch but couldn't gain on the top ones late. ROYAL TROON rated off the pace, raced four wide around the turn and lacked a rally. PASSING PRINCESS chased the pace along the inside into the stretch and gave way. ALINA'S LAD failed to menace. WONDER WAY tracked the pace three wide, then was caught in tight entering the turn and tired. UPSHOTBEST chased the pace three wide into the turn and faltered. STEPH'S SONSET showed little. The rider of ROYAL TROON lodged an objection against the rider of FLY SO FAST for alleged interference racing into the turn. The claim of foul was not allowed.
