SPEIGHT THE HALO chased the pace along the inside, eased out and rallied to catch HUGH AND ME at the eighth pole, then was all out to prevail. HUGH AND ME showed speed along the rail into the stretch, then couldn't resist the winner while continuing on with good courage to hold the place. MATT'S A GIANT reserved off the pace, swung wide for the stretch run and rallied to be up for the show. FISHERMAN'S WHARF unhurried early, saved ground and

closed well to just miss the show. DON'T SAY NO tracked the leaders into the stretch but had no late response. CAR THIEF tracked the pace four wide around the turn and weakened. RETIRE TO WHAT chased the pace three wide around the turn, then tired. NINEINTHENINE failed to menace. WANNABE saved ground to no avail. BUBBER was not a factor. SOUTHERN GLITTER was outrun. MCCARTY chased the pace off the rail to nearing the quarter pole, then faltered.
