SABOYA stalked the pace, moved to take over on the far turn and was all out to hold PEER REVIEW safe. The latter, off slowly, stalked the pace three wide into the stretch and continued on with good courage to prove second best while unable to get to the winner. SOIXANTE DIX made the pace along the inside to midway of the far turn and tired. NEUF LA BANQUE (PER) saved ground into the stretch and faltered. ARDENT LOVER was not a factor. SLACKS trailed after breaking slowly.
