FOREST GROVE set the pace along the inside, drew clear in midstretch, then was fully extended to last over NOTORIOUS ROGUE. The latter, well placed while saving ground, eased out for the stretch run and was gaining on the winner at the finish. NIGHTMARE AFFAIR reserved early, advanced into contention three wide on the far turn, then lacked a late response. A. J. MELINI allowed to settle, raced three wide on the far turn and tired. VICTORY LIGHT saved ground and failed to menace. SPEEDJAMA chased the winner to nearing the stretch and faltered. DECIBEL was through after a half mile. WITNESS THIS showed little.
