Footnotes

PLATINUMPLUS unhurried early, angled out for the stretch run, rallied to catch CRAWFORD COUNTY inside the sixteenth pole and won going away.

CRAWFORD COUNTY vied for the lead along the rail, drew clear in the stretch but couldn't match strides with the winner late. ROAD TRACK'S DREAM unhurried early, rallied along the rail to loom a threat in midstretch, then flattened out. DUBAI'S CONNECTION tracked the pace along the inside into the stretch and gave way. DOUBLE DINGHY DAY outrun early, passed tired rivals in the drive. IWOMAN failed to menace. LESSEROFTWOEVILS was not a factor. RUN JAMAICAN'S RUN allowed to settle after breaking slowly, bumped with ARCTIC EVA in the stretch and never threatened. GATOR'S TRACKS hit the rail entering the first turn, tracked the pace, raced three wide around the far turn and tired. ARCTIC EVA chased the pace three wide, made a run to try the leaders on the far turn, then was faltering when she bumped with RUN JAMAICAN'S RUN in early stretch and steadied. DESERTSTORMELITE raced four wide and was done early. I'LL TAKE TWO vied for the lead outside CRAWFORD COUNTRY to the top of the stretch, then faded.
