ACT OF BLUES tracked the pace three wide around the turn and closed to be up for the place while no match for the winner. DEFAMER chased the pace into the stretch and gave way. JEANNIE S chased the pace four wide to midway of the turn, then tired. MARI GOLD GIRL outrun early, improved her position in the drive. PROUD LUCY showed brief speed and faltered. LYNN'S PRINCESS failed to menace. OH MANDIE was not a factor. GHOST TOWN KAT showed early foot and faded. OASIS THE JAK broke poorly, saved ground while racing in contention to midway of the turn, then dropped back. SIN THEN REPENT was outrun. ESME chased the pace into the turn and stopped.
