Footnotes

PECKY'S BOY showed speed off the rail, increased his margin in midstretch, then was fully extended to prevail. RODAN stalked the pace along the inside, eased out in the stretch and was gaining slowly on the winner at the finish. HOMBRE OSCURO chased the pace, then drifted out at the top of the stretch and tired. DEPUTY DUKE chased the pace four wide, then bumped hard with FREEDOM LIGHT at the top of the stretch and faltered. PROUD TRAIL saved ground and never threatened. FREEDOM LIGHT chased the pace three wide, then bumped soundly with DEPUTY DUKE at the top of the stretch and faded. ONE LUCKY PUNCH trailed after being checked at the start. The rider of FREEDOM LIGHT lodged an objection against the rider of HOMBRE OSCURO for alleged interference at the top of the stretch. The claim of foul was not allowed.
