SUPERBOWL PICC reserved off the pace, raced three wide the turn and rallied under pressure to be up late. EASTER BUTTER rated off the pace, angled to the inside and slipped through along the rail to get the lead inside the eighth pole but couldn't hold off the winner in the closing strides. MISS GLITTERMAN showed speed along the inside, came off the rail for the drive and weakened in the final sixteenth. HOLD HER WAGER chased the pace into the stretch and tired. BOONE'S GOLD was no factor after breaking poorly. FLAG HER ON failed to menace. BONE OF CONTENTION saved ground and faltered.
