Footnotes

IRON POST bounced around with MYLILMANWIL in the run to the first turn, rallied three wide around the far turn, moved to take over inside the eighth pole, then was all out to last over FRANKLINPARK. The latter, reserved off the pace, angled out in the stretch and rallied to just miss. COOL COLONY set the pace along the inside to past the eighth pole, then weakened. LEGAL POWER stalked the pace along the inside, angled out leaving the far turn and gave way. AS DE COPAS prompted the pace outside COOL COLONY to nearing the stretch, then tired. PORTMAN was outrun. CAUGHT ME LOOKING was no factor after being steadied soon after the start. ERUPTION ZONE tracked the pace into the far turn and faltered. LIZARD'S REPENT stalked the pace into the far turn, then faded. MYLILMANWIL bounced around with IRON POST in the run to the first turn, pressed the pace into the backstretch, stopped, was pulled up on the far turn and walked off.
