Footnotes

A BIT OF MADNESS stalked the pace along the inside, angled outside the leaders for the stretch run and rallied to be up late. TOUCHED BY MADNESS sprinted to a clear lead while angling over to the rail, responded when challenged by PASS PLAY on the far turn and into the stretch but couldn't hold off the winner late. VOORHEE'S BALLAD tracked the pace, swung out for the stretch run and finished willingly for the show. PASS PLAY chased the pace, made a run to try the leader around the far turn and into the stretch, then weakened late. SIGHTSEEING well placed while saving ground, didn't do enough late. SPANISH HARLEM (IRE) saved ground and failed to menace. DOUBLE DOORS (GB) off slowly, was unhurried early, then gained some ground in the drive. COLORFUL JUDGEMENT rated in striking position off the pace, lacked a rally. NOMBRE DE DIOS (BRZ) was not a factor. DAVID K was outrun.
