Footnotes

QUANTITY unhurried early, raced three wide around the far turn, then rallied to catch KING TING inside the eighth pole and edged away. AUSSI AUSTIN rated in striking position off the pace, angled out for the stretch run and rallied for the place. KING TING (IRE) reserved early, advanced three wide down the backstretch to reach the leaders, moved to take over on the far turn, made the pace to inside the eighth pole and weakened. BLUEMBER allowed to settle, saved ground, eased out and made a run to reach contention in the stretch but couldn't gain late. EXETER ROAD stalked the pace along the inside, eased out while making a run to reach the leaders on the far turn, then gave way. FOOLISH TIGER failed to menace. RULE NUMBER SIX raced three wide and tired. MACARTHUR CAUSEWAY stalked the pace, gained a brief lead on the far turn, then was fading when steadied in the stretch. MODEST chased the pace into the far turn and faltered. POST RANCH raced three wide and was through after six furlongs. ALBERT set the pace along the rail into the far turn, then had nothing left.
