**Footnotes**

THREE MIRACLES set the pace under pressure along the inside, edged away in early stretch, then responded when challenged by LIQUID AMBER and held that rival off while coming out a bit nearing the wire. LIQUID AMBER raced with the pace four wide around the turn, couldn't stay with the winner in early stretch, then came on to try that rival again late but was outgamed to the wire. HANDSOME BRUNO pressed the pace three wide around the turn, was outmoved by the top ones in the stretch, then gained some ground late. SUCCESFUL RETURN raced three wide and failed to menace. DANE K. reserved racing along the inside, tired in the drive. STICKY SKIPPY hit the gate at the start, pressed the pace outside THREE MIRACLES into the turn, then was dropping back when steadied from close quarters nearing the quarter pole and faltered. MAJICAL WAY was through early after breaking poorly. The rider of LIQUID AMBER lodged an objection against the rider of THREE MIRACLES for alleged interference in the stretch. The claim of foul was not allowed.
