**Footnotes**

HEAR THE WORD reserved early, angled out for the stretch run, then rallied outside CABEUS to be up late. CABEUS rated off the pace, rallied to gain the lead inside the eighth pole but couldn't resist the winner late. ZULU WARRIOR chased the pace off the rail, moved to take over on the far turn, made the pace to past the eighth pole, then gave way. GREYRUNFORNV unhurried early, saved ground and improved his position. COSSIO outrun early, swung wide for the stretch run and never threatened while passing tired rivals. CHILEAN STEP off slowly, was taken in hand early and failed to menace. BIG SCOOP raced four wide and tired. MORE ANON bumped and steadied from between rivals in the early going, was attempting to move into contention when he stumbled in the stretch and failed to recover. TORMENTO bumped with EVIL TOWN in the early going, stalked the pace three wide to nearing the stretch, then faltered. STEDFAST CAT bumped with MORE ANON in the early going while sprinting to a clear lead, made the pace along the inside into the far turn and faded. EVIL TOWN bounced around between rivals in the early going, stalked the pace four wide into the far turn, then had nothing left. SIDE PARTY RALPH trailed after clipping heels racing into the first turn.
