Footnotes

HEY BYRN stalked the pace three wide, rallied to take over at the eighth pole and drew off when asked. WONDER MON off slowly, was unhurried early, angled out for the stretch run and closed to be up for the place while no threat to the winner. SLEUSE set the pace along the inside to nearing the eighth pole, then gave way. BORDEAUX BANDIT prompted the pace outside SLEUSE, made a run at the lead racing into the stretch, then tired. COLD TRIAL showed early foot while saving ground and faltered. ALAAZO stalked the pace to the far turn, then faded.
