Footnotes

PISTORIA rated off the pace, rallied three wide to take over leaving the far turn, then was fully extended to hold off WET ONE (IRE). The latter, unhurried early, raced four wide around the far turn and rallied for the place. PATIENT APPROVAL broke in the air, moved up quickly to set the pace along the rail to past the quarter pole, then weakened. FLEET ALLAIRE stalked the pace to nearing the stretch, then gave way. SMOKIN ALI reserved off the pace, advanced around the far turn to reach contention, then tired in the final eighth. WAQUOIT'S DANCE raced four wide and failed to menace. ROUGH WINTER was caught in tight at the start, then was no factor while saving ground. RUNAWAY JOAN tracked the pace, rushed up on the backstretch to press PATIENT APPROVAL into the far turn, then faltered. R U DREAMING stalked the pace off the rail, then was fading when steadied on the far turn.
