SIVA unhurried after breaking awkwardly, angled out in the stretch, then rallied to be up in time. TALE OF MY CAT chased the pace along the rail, moved to take over just inside the eighth pole and opened a clear lead but couldn't resist the winner late. BOCONO tracked the pace, was steadied in behind the leader leaving the backstretch, advanced to reach contention in midstretch but couldn't keep pace with the top ones. A. P. CINO reserved off the pace, raced three wide around the turn and had no response. NUESTRA SENOR chased the pace three wide to inside the eighth pole and tired. DERBY WATCH showed speed along the inside to the eighth pole, then faltered. ZEDDEMORE chased the pace off the rail into the stretch and faded. GEORGE AND JOHN trailed after breaking slow and being steadied at the start.
