Footnotes

MIDNITE SILVER stalked the pace, eased out and rallied to take over just inside the eighth pole, then drew clear. MONEY IN MOTION reserved off the pace while saving ground, angled out for the stretch run and rallied for the place while unable to get to the winner. PECKY'S BOY set the pace under pressure along the rail, responded when CINNAMON BEACH gained a slim lead leaving the far turn, then weakened in the final eighth. DYNAMIC BOY stalked the pace along the inside into the stretch and gave way. CINNAMON BEACH pressed the pace outside PECKY'S BOY, gained a slim lead leaving the far turn, maintained that advantage to past the eighth pole, then tired. LE MANS allowed to settle, lacked room in behind rivals along the inside in the stretch and failed to menace. TOM KITTEN stalked the pace three wide to nearing the stretch, then faltered. DECAF AGAIN was outrun. DR. CHASE stalked the pace four wide to nearing the stretch and faded. FRANKLINPARK showed little.
