HEAD COUNT off slowly, tracked the pace three wide, moved to take over command entering the stretch and drew clear under urging. VAUNTED VAMP rated off the pace while saving ground, angled out for the stretch run and gained the place. SENORITA (ECU) unhurried after breaking slowly, raced four wide on the far turn and rallied mildly for the show. CONFORMAL wearing a nasal strip, chased the pace into the far turn and tired. EXQUISITE AFFAIR sprinted to a clear lead racing off the rail, then faltered in the drive. DORM wearing a nasal strip, was through early. GITANITA showed nothing. BEEZER TOO was always outrun.
