PEER REVIEW wearing a nasal strip, was up close while saving ground, angled out at the top of the stretch and rallied to draw clear under a strong hand ride. STAR BRIGHTLY reserved early, rallied three wide around the far turn and gained the place while being outfinished by the winner. HEDGE RATIO rank under restraint early, saved ground into the stretch but couldn't gain late. HASTY SWORD outrun early, improved her position without threatening. BLINK rated in striking position off the pace, swung wide for the stretch run and lacked a late response. VELVET DRIVE tired from good position. MATTIE KATE sprinted clear along the inside, then faltered in the final eighth. GOLD PIECE turned in a dull effort.
