OUTTA THE PARK outrun after breaking slowly, swung wide for the stretch run, rallied to catch MEAMA inside the eighth pole and drew clear. CIVILITY CAT unhurried early, checked to avoid running up on rivals leaving the far turn, recovered and angled to the outside for racing room, then closed to prove second best. DRESS TO IMPRESS reserved off the pace, moved into contention four wide on the far turn, then gained the show while being outfinished by the top ones. NAULT allowed to settle, advanced between horses leaving the far turn to loom a threat in midstretch, then tired. AWESOME REEF taken in hand, saved ground around the far turn, was forced to check at the top of the stretch when caught in behind a wall of horses and failed to threaten. COMEBACK TO ME steadied in the early going, chased the leaders three wide to the top of the stretch and gave way. ROYAL DOVE well placed while saving ground into the stretch, faltered. MEAMA stalked the pace outside BON FILLE, moved to take over leaving the far turn and edged away, then faded in the drive. BON FILLE set the pace along the rail to nearing the stretch and stopped. MASTER PROSPECT was done early.
