MANNINGTON pressed the pace outside CHECKLIST, took over from that rival in the stretch and drew clear. CHECKLIST set the pace under pressure along the inside into the stretch, then couldn't stay with that rival while continuing on with good courage for the place. IMPERIAL COUNCIL rated off the pace, raced three wide around the turn and rallied to be up for the show. CAIXA ELETRONICA reserved off the pace, angled out and advanced four wide around the turn to reach contention but had no further response. FINE FLYER outrun after hesitating at the start, passed tired rivals in the drive. BRAVE VICTORY failed to menace. ROYAL VINDICATION chased the pace three wide, made a run at the leaders on the turn, then tired. WEST EXPRESS saved ground and faltered. JUST A COINCIDENCE was done early. FREEDOM BAY ducked out at the start, chased the leaders four wide into the turn and faded.
