CARIBBEAN LADY chased the pace, rallied to take over at the eighth pole, opened a clear lead inside the sixteenth pole, then was all out to last over SNOW TRIAL. The latter, allowed to settle, swung out for the stretch run and finished full of run for the place. MISS MAGGIE GIRL rated off the pace after bumping with JOYCE MARIE at the start, checked to avoid running up on BECAUSE I LIKE IT nearing the end of the backstretch, recovered and rallied for the show. ROSA SALVAJE outran AROYALSWEET for the lead, made the pace along the inside to nearing the eighth pole, then gave way. JOYCE MARIE

unhurried after bumping with MISS MAGGIE GIRL at the start, swung wide for the stretch run and closed with a belated rally. AYOUMILOVE reserved off the pace, advanced three wide leaving the turn to loom a threat but couldn't sustain her bid. BECAUSE I LIKE IT saved ground and failed to menace. CHRISTINA D'ORO well placed after breaking a step slowly, lacked a late response. NIKI'S ICE tracked the leaders along the inside, eased out and tired. JUST SAY GOODBYE chased the pace three wide into the stretch and faltered. SYLVIA'S TEMPO off a step slowly, was not a factor. AROYALSWEET showed brief speed along the rail and faded.
