Footnotes

TRUENO JAK bobbled at the start, chased the pace four wide, moved up three wide to engage the leaders leaving the turn, came in a bit in the stretch, then dueled with those rivals to deep stretch and prevailed. DISTINCTIVE PIC vied for the lead three wide, moved in a path when VILLERE dropped back, was dueling for the lead when caught in tight briefly in the stretch and continued on gamely while being edged to the wire. SALT WATER COWBOY vied for the lead along the inside throughout and held on well while being edged to the wire by the top ones. BIZARRO reserved off the pace, improved his position without threatening. HOT LANTA stalked the pace duel around the turn, then gave way. HUNTER JAK tracked the leaders three wide around the turn and tired. FRANKIE RULES chased the pace four wide to midway of the turn, then faltered. VILLERE showed speed between horses into the turn and faded. FLYING APTITUDE was not a factor. EL KIWI off slowly, was outrun. PURE COINCIDENCE was done early after breaking slowly. THE RIDER OF DISTINCTIVE PIC LODGED AN OBJECTION AGAINST THE RIDER OF TRUENO JAK FOR ALLEGED INTERFERENCE IN THE STRETCH. THE CLAIM OF FOUL WAS NOT ALLOWED.
