Footnotes

SWEEPING EVA set the pace under pressure along the inside, was headed nearing the sixteenth pole, bumped NOONTIME PLEASURE inside the sixteenth pole and came again to prevail. NOONTIME PLEASURE chased the pace three wide into the stretch, gained a slim nearing the sixteenth pole, then bumped with SWEEPING EVA soon after and was edged to the wire. CHEEKS away alertly when she popped through the gate just prior to the start, was rated off the pace into the stretch and gained the show while no threat to the top ones. LUCKY LYNN SAY pressed the pace outside SWEEPING EVA and tired. HAZY PROMISE was outrun. DEHERE'S DREAM showed little. Following a stewards inquiry and a claim of foul by the rider of NOONTIME PLEASURE against the rider of SWEEPING EVA for interference inside the sixteenth pole, SWEEPING EVA was disqualified and placed second.
