DE BERTIE unhurried after being steadied from tight quarters at the start, rallied strongly three wide on the far turn, caught APPLE OF KENT inside the eighth pole and drew clear under urging. APPLE OF KENT stalked the pace, moved to take over leaving the far turn and was clearly second best while unable to stay with the winner through the final eighth. SCRATCH PAD sprinted to a clear lead along the inside, then gave way in the drive. HUMBLE CLERK reserved in striking position off the pace, failed to menace. RUN FOR JOY chased the pace along the inside into the far turn and faltered. DYNAMEESCH was never a factor. CASH'S PRIDE was outrun while saving ground.
