Footnotes

ANNUAL APPEAL unhurried early, swung out for the stretch run and rallied to be up late. HARLAN'S PRINCESS reserved while saving ground, steadied in behind rivals on the turn, steadied again and angled outside PROUD AND SALTY in early stretch, rallied to gain a brief lead at the sixteenth pole but couldn't match strides with the winner late. BAIL OUT MOM set the pace under pressure along the rail, edged clear in the stretch, then gave way in the final sixteenth. EXTREM QUALITY stalked the pace along the inside into the stretch and tired. PROUD AND SALTY pressed the pace outside BAIL OUT MOM to the top of the stretch, then faltered. CROWN GLORY well placed after breaking a step slowly, raced three wide around the turn and couldn't keep pace in the drive. YOU TALKING TO ME was never a threat after being steadied when bumped by SEXY THUNDER at the start. SEXY THUNDER steadied when she bumped with YOU TALKING TO ME at the start, then steadied again in the early going and was not a factor. BIT OF HEAVEN was outrun. A TRIPPI MOMENT was done early. MARIBETH raced three wide and faded. OLIVE EYE stumbled at the start, chased the pace three wide to nearing the stretch, then stopped and was eased in the stretch run.
