**Footnotes**

DEVILLIOUS checked while breaking awkwardly, rushed up three wide to contest the pace on the first turn, stalked outside to the turn, took the lead in upper stretch then held off RIOTOUS MISS under steady pressure. RIOTOUS MISS reserved early after breaking slowly, moved into contention while three wide along the backstretch, made a run to threaten in upper stretch but couldn't get by the winner while holding well for the place. BAIL MONEY was reserved early while saving ground, lacked clear sailing along the inside on the turn, swung out entering the stretch, altered course to the outside in upper stretch then finished willingly to gain a share. RIZZI GIRL lodged a rally five wide to reach contention on the turn then flattened out. TIFFISH chased between horses for six furlongs and tired. BLONDAWAY set the pace along the rail to the top of the stretch and tired. VICTORIOUS VICKI raced in good position along the rail to the turn and lacked a strong closing bid.
