STAKES Palm Beach S. Grade 3 - Thoroughbred

FOR THREE YEAR OLDS. Free nomination by Saturday, February 20, 2010, \$1,500 to pass the entry box and \$1,500 additional to start, with \$150,000 Guaranteed. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$60,000, \$20,000 to second, \$10,000 to third, \$5,000 to fourth, \$3,000 to fifth and \$2,000 to sixth. Supplemental nominations may be made at time of entry at a fee of \$6,000, which includes entry and starting fees. Weight: 122 lbs. Non-winners of a graded/group stakes over a mile on the turf in 2009-2010 allowed 2 lbs.; of a sweepstakes at a mile or over in 2009-2010 4 lbs., of two races other than maiden or claiming at a mile or over on the turf 6 lbs. In the event this stakes is taken off the turf, it may be subject to downgrading upon review of the Graded Stakes Committee. Trophy to the winning owner. Closed Saturday, February 20, 2010 with 39 nominations. (If deemed inadvisable to run this race over the turf course, it will be run on the main track at One Mile and One Eighth) (Rail at 96 feet).

Footnotes

PADDY O'PRADO pressed the pace along the rail, moved to take over leaving the far turn and opened a clear lead, then remained clear to the wire under pressure. DEAN'S KITTEN was stalking the pace when steadied along the inside on the first turn, continued to save ground into the far turn, angled out for the drive and rallied to prove second best. OUR CHAMPION unhurried early, raced three wide around the far turn and closed to gain the show. ASPHALT set the pace under pressure outside PADDY O'PRADO to nearing the stretch, then gave way. BIM BAM bumped between rivals at the start, chased the pace to midway of the far turn, then tired. LETHAL COMBINATION rated off the pace after bumping with BIM BAM at the start, saved ground and had no response when asked. CENTER DIVIDER bumped with BIM BAM at the start and failed to menace. CAT PARK was not a factor. MUTINY reserved off the pace, raced three wide around the far turn and faltered.
