Footnotes

CHIA SPICE chased the pace three wide, moved to take over on the turn, then edged away under urging. BLING BANG rated off the pace after being steadied from tight quarters on the backstretch, steadied again in traffic on the turn, recovered and rallied to be up for the place. MARINE unhurried early, swung out for the stretch run and closed well late for the show. RAGLIN RIVER bumped with DEVIL'S JOY at the start, advanced four wide to reach contention on the turn, then gave way in the final eighth. A P ASSET raced five wide and tired. DEVIL'S JOY reserved off the pace after bumping with RAGLIN RIVER at the start, faltered in the drive. GOOD AND GRATEFUL showed speed along the inside, then was fading when she hit the rail on the turn. CORINTHIA showed speed off the rail to midway of the turn, then had nothing left.
