ULTIMATE SPEED showed speed along the inside, increased her margin on the turn, then was all out to last over DEVIOUS MADDY. The latter, unhurried after being steadied from close quarters soon after the start, closed well for the place while unable to catch the winner. WHISTLE MY WAY chased the pace off the rail into the stretch but couldn't gain late. LLOYD HARBOR rated off the pace, closed with a mild response to finish on even terms with ACQUISITION. The latter, allowed to settle after breaking slowly, raced four wide around the far turn and gained some ground to dead heat with LLOYD HARBOR. ALGUNA failed to menace. GO SANDY GO well placed early, tired.
