Footnotes

MOUDEZ (IRE) unhurried after breaking slowly, circled rivals four wide on the far turn to reach contention, moved to take over inside the eighth pole, then drew clear. RAHYSTRADA vied for the lead along the rail into the stretch, then couldn't match strides with the winner in the final eighth while holding the pace. BROOKLYN'S SMART reserved off the pace, saved ground while advancing into the stretch but couldn't sustain his bid. LA NEIGE (GB) allowed to settle, saved ground and improved his position without threatening. BIGGERBADDERBETTER tracked the pace into the stretch and gave way. BALLET FEVER failed to menace. VANQUISHER outrun early, raced three wide on the far turn, then was forced out by BALLET FEVER at the top of the stretch and never threatened. VOORHEE'S BALLAD vied for the lead outside RAHYSTRADA to the top of the stretch, then tired. LEADING ON rated off the pace, steadied in traffic on both turns and faltered. WILD UNION tracked the pace three wide into the far turn, then faded. PRIDE OF SEATTLE chased the pace into the far turn, then had nothing left. TOUCHDOWN PEYTON showed little and was eased in the stretch run.
