**Footnotes**

SO LIKE A TIGER chased the pace three wide, moved to gain a slim lead at the quarter pole, dueled with ROCKET ZEE, then bumped with that rival late and prevailed. ROCKET ZEE showed speed off the rail, responded when headed by SO LIKE A TIGER at the quarter pole, bumped with that rival in deep stretch while dueling for the lead and was edged to the wire. HUDSON TOWNSHIP rated off the pace, made a run to loom a threat in the stretch but couldn't gain late. AMAZON HOLLY raced with the pace four wide to nearing the stretch, then gave way. PARIS WEEKEND unhurried early, raced three wide around the turn, angled out and passed tired rivals. SMALL TALK failed to menace after being outrun early. ROMA TOMATO was not a factor after being caught in tight at the start. COUP DE THEATRE turned in a dull effort while racing five wide. GOODGOLLYMYHOLLY pressed the pace along the rail to nearing the quarter pole, then tired. BLUE SKY GIRL saved ground and faltered. GIMMEAHUG chased the pace four wide to the turn, then faded. The rider of ROCKET ZEE lodged an objection against the rider of SO LIKE A TIGER for alleged interference in the final sixteenth. The claim of foul was not allowed.
