MARTINI MADNESS vied for the lead along the rail, then edged away through the stretch under pressure. RICHMOND COUNTY vied for the lead outside MARTINI MADNESS into the stretch, then weakened and just saved the place. FARETTI off slowly, was unhurried early, saved ground around the turn, eased out and rallied to just miss the place. DANGEROUS TRICK chased the pace along the rail into the stretch but couldn't gain ground when asked. BLINGS EXPRESS chased the leaders off the rail into the stretch and gave way. PLAY EIGHTEEN reserved after bumping with DARKER MOON in the early going, angled out in the stretch and closed with a mild response. UNLIMITED SPIRIT raced three wide and failed to menace. INDIRECTLY A. P. was not a factor. DARKER MOON was outrun after being bumped between rivals in the early going. GENTLEMANS CODE bumped with DARKER MOON in the early going, tracked the leaders four wide around the turn and tired. SEVEN KIND chased the pace three wide to the quarter pole, then faltered.
