SCOOTER GIRL set the pace along the inside, edged clear in early stretch, then ducked out when struck left handed inside the eighth pole, was straightened away and remained clear to the wire. NAME IN LIGHTS prompted the pace outside SCOOTER GIRL into the stretch, then couldn't stay with that rival while proving second best. ICU LATER chased the leaders three wide around the turn, then couldn't keep pace with those rivals in the drive. GOLDEN CELEBRITY tired from good position. I'MAGOLDENGIRL chased the pace along the rail into the stretch, then faltered. SECRET INSPIRATION was no factor after hesitating at the start. DIAMOND MIA was outrun. C. C. GLIDER showed early foot, raced three wide on the turn and faded. There was a stewards inquiry into SCOOTER GIRL ducking out in the stretch. No action was taken.
