By subscription of \$75 on Saturday, February 21, 2009, which should accompany the nomination, \$750 to pass the entry box and \$750 additional to start, with \$75,000 Guaranteed. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$45,000, \$15,000 to second, \$7,500 to third, \$3,750 to fourth, \$2,250 to fifth and \$1,500 to sixth. Supplemental nominations may be made on Thursday, March 5, 2009, at a fee of \$3,000, which includes entry and starting fees. Weight 122 lbs: Non-winners of a sweepstakes, allowed 2 lbs.; \$30,000 twice in 2008/2009 4 lbs.; \$30,000 once in 2008/2009 6 lbs.; a race other than maiden or claiming since in 2009 8 lbs. Starters to be named through the entry box by the usual time of closing. This race will be limited to 14 starters, with Also Eligibles. High Weights Preferred with second preference to horses with the highest lifetime earnings. Trophy to the winning owner.

PEISINOE in hand while making the pace off the rail, edged away in midstretch, then was fully extended to prevail. ZEE ZEE prompted the pace outside PEISINOE, couldn't stay with that rival in midstretch but continued on with good courage to prove best of the rest. PEACH FLAMBE stalked the pace three wide into the stretch but didn't do enough late. SO GLITZY rated off the pace, raced four wide around the turn and lacked a rally. CAT CAN DO failed to menace after being steadied at the start. YOU ASKED reserved along the inside, angled out for the stretch run and had no response when asked. ANNABILL tracked the pace into the stretch and tired. LA BLANQUEADA was outrun.
