WAR DANCER chased the pace off the rail, moved to take over in early stretch, then edged away under steady pressure. FEDERAL AGENT rated off the pace, steadied outside the incident leaving the first turn, saved ground around the far turn, then closed with a mild response for the place. AUTOBAHN LEGEND reserved along the inside, checked trying to avoid incident on the first turn, swung out for the stretch run and rallied for the show. LUCK SEEKER steadied at the incident leaving the first turn, tracked the leaders four wide into the stretch, then weakened. OISTIN'S TOWN stalked the pace three wide into the stretch, then gave way. UNCLE GARE checked avoiding the incident on the first turn, saved ground and lacked a late response. SANTO DIVINO set the pace along the rail into the stretch, then tired. DESAFINADO LIGHT steadied along the inside in the early going, swung wide leaving the first turn avoiding the incident and was not a factor. RONTOS' DREAM was outrun. ALL ALEX unhurried early, unseated his rider when caught up in the incident on the first turn. LAYTON REGISTER rated off the pace, was bumped hard by BOSS MAN leaving the first turn unseating his rider. BOSS MAN was chasing

the pace when he clipped heels leaving the first turn, unseated his rider causing a chain reaction of trouble. THERE WAS A STEWARDS INQUIRY INTO THE INCIDENT ON THE FIRST TURN. NO ACTION WAS TAKEN.
