HYPER rated off the pace, raced three wide around the far turn, swung out, rallied to take over in the stretch, then was all out to last over FINALE. The latter, unhurried after being steadied in the early going and again on the first turn, swung out for the stretch run, then rallied to just miss. BURN THE MORTGAGE reserved off the pace, finished willingly to be up for the show while unable to match strides with the top ones. BAD DEBT stalked the pace off the rail into the stretch, then weakened. FORWARD MARCH set the pace along the inside to nearing the eighth pole, then gave way. HOBBS rated off the pace, steadied in traffic on the backstretch, advanced three wide around the far turn to loom a threat in midstretch, then tired. SPACE RACE pressed the early pace along the rail, eased back to stalk the leader, then steadied on the far turn and faltered. WHERE'S THE BABY stalked the pace four wide into the stretch and faded. STORMY LORD chased the pace to nearing the stretch, then had nothing left.
