TAREK chased the pace four wide, was outmoved in midstretch, then closed to gain the place while no match for the winner. YONAGUSKA vied for the lead three wide into the stretch and tired. LIBERTY TOWNSHIP vied for the lead along the rail into the stretch and faltered. FISTFITE vied for the lead between horses, then was steadied from tight quarters approaching the quarter pole and faded. SPARKLING SABRE trailed.
