Footnotes

BEST APPLE showed speed off the rail, responded when headed on the turn, regained the lead in early stretch, then was fully extended to hold off MANUEL R. The latter, reserved early, angled to the outside for racing room on the backstretch, raced four wide around the turn and closed to prove second best while unable to get to the winner. WILD REPENT rated off the pace, lacked a late response while gaining the show. HARBOR RIDGE chased the pace along the inside, moved up to gain a slim lead on the turn, maintained that advantage into the stretch, then tired. NO IT'S TRUE chased the pace three wide into the stretch, then faltered. HURRICANE TIGER saved ground and faded.
