ARENA ELVIRA stalked between horses, split rivals in deep stretch and rallied. SISTER RESISTOR pulled along the inside and failed to sustain a bid. DIFFERENTIATE raced four wide on the backside and lacked a rally. CHISTOSA chased three wide and tired. JASMINE GARDENS chased between foes, saved ground on the turn and failed to respond. SUPERIOR SELECTION vied outside and tired. BANKER'S BUY had a four wide trip and failed to respond.
