Footnotes

TIGRINA raced three wide around the turn, came outside the leaders for the drive, was rallying when she drifted in at the eight pole impeding AVAST, moved to take over at the sixteenth pole and was fully extended to prevail. DEVIL'S FANTASY reserved early, raced three wide on the turn, angled to the outside for the drive and rallied to be up for the place. KICK STAGE tracked the pace, was forced to steady when she lacked room on the turn and again in the stretch, came outside IMMERSSED and finished willingly while being edged for the place. IMMERSSED set the pace under pressure along the inside, came off the rail for the stretch run and weakened late. EVERYTHINGUNEED rated in striking position off the pace, lacked the needed late response. COUNTESSA unhurried early, passed tired rivals without threatening. AVAST chased the pace three wide into the stretch, then was taken up when put in tight by TIGRINA at the eighth pole and tired. FLEET HUNTRESS saved ground to no avail. PALACE EMBLEM pressed the pace outside IMMERSSED, then was checked from between AVAST and KICK STAGE in early stretch and faltered. SO STRIKING was never close. PRETTY ROSE showed little. AIR FALCON was outrun after hitting the gate at the start. Following a stewards inquiry and a claim of foul by the rider of AVAST against the rider of TIGRINA, TIGRINA was disqualified and placed seventh for interference to that rival at the eighth pole.
