Footnotes

CLAIMING VICTORY rated off the pace, angled out for the stretch run, rallied to catch BE MY LOVE inside the eighth pole and edged away. SATAN'S MISTRESS outrun after being checked when she threw her head at the start causing her rider to lose his right iron briefly, saved ground into the stretch, eased out and rallied to be up for the place. BE MY LOVE chased the pace off the rail, moved to gain a brief lead in midstretch, then weakened. CINDY CATA showed speed along the rail to nearing the eighth pole and gave way. WILD ORATION broke a step slowly, stalked the pace along the inside into the stretch, then tired. CALL MY LAWYER unhurried early, swung out for the stretch run and never threatened. ZULBABY failed to menace. SUNRISE KITTY was not a factor. JUST BLESSED chased the pace three wide around the turn and faltered. VALVERDINA chased the leaders four wide to nearing the stretch, then faded.
