## **Footnotes**

PAUL'S ACE showed speed along the inside, drifted out a bit leaving the turn, then responded to pressure and edged away. BOBBY B. GOODE chased the pace five wide around the turn and rallied to be up for the place. COMPLIANCE OFFICER pressed the pace outside PAUL'S ACE to nearing the stretch, then weakened. UNDERSOLD off slowly, was angled in to save ground around the turn, made a run along the rail to reach the winner in the stretch but couldn't sustain his bid. RUN FOR SAMI bumped with SPARTAN GENERAL at the start, raced in contention three wide into the stretch and lacked a rally. ROCAMADOUR saved ground and had no late response. TALE OF VICTORY pressed the pace three wide around the turn and gave way. HOLY POPPI was no factor after breaking slowly. SPARTAN GENERAL was outrun after bumping with RUN FOR SAMI nearly unseating his rider at the start. BAMBINI was never a threat after being steadied on the backstretch. STORM'N WARRIOR tracked the pace along the inside into the stretch, then tired.
