



WARBLING away alertly, showed speed off the rail into the stretch, then increased her margin to the wire under urging. TAR HEEL MOM chased the pace four wide into the stretch but couldn't stay with the winner while proving second best. THUNDERS DOVE chased the pace off the rail around the turn and gave way. PRETTY PROLIFIC saved ground and never threatened. PINKARELLA chased the pace along the rail to nearing the stretch, then tired. SARATOGA TANGO was not a factor. FIRST PASSAGE hit the gate at the start, tracked the pace four wide around the turn and faltered. KAYS AND JAYS chased the pace three wide to midway of the turn, then faded. HONCHIS'N PONCHIS trailed and was eased in the stretch run.
