AINSLEY stalked the pace along the inside, eased out for the stretch run, then rallied to catch DADDYS JEWEL late and edged away. DADDYS JEWEL vied for the lead outside TAXI DANCER, edged clear from that rival in the stretch but couldn't resist the winner late while clearly best of the rest. NAIGUATA unhurried early, passed tired rivals in the drive to gain the show. CALL MY LAWYER off slowly, stalked the pace three wide around the turn, then tired. TAXI DANCER vied for the lead along the inside to nearing the top of the stretch and faltered. JOYCE AND ME showed brief speed and faded. SWEET XARENI saved ground and was through after a half mile. WEST COAST LADY stumbled at the start and was done early. AUDREY raced three wide, stopped and was eased in the stretch run.
